**THE ESTABLISHMENT OF THE INTERINSTITUTIONAL WORKING  
GROUP FOR IMPLEMENTING MEASURE 51 OF THE ACTION PLAN  
OF THE NATIONAL DRAFTING STRATEGY**

Pursuant to paragraph 3 of Article 102 of the Constitution of point 1 of Article 12 of Law No. 9000, dated 30.1.2003, "On the organization and functioning of the Council of Ministers", of the decision no.259, dated 9.5.2018, of the Council of Ministers, "On the approval of the National Diaspora Strategy 2018-2024 and the Action Plan".

**I HEREBY ORDER:**

1. Establishment of the interagency working group for the implementation of Measure 51 of the Action Plan of the National Strategy for Diaspora, approved by the Council of Ministers Decision No. 259, dated 9.5.2018.
2. The inter-institutional working group shall consist of:
  - Minister responsible for the diaspora chairman;
  - Minister responsible for external affairs member;
  - Minister responsible for finances member;
  - Minister responsible for education member;
  - Minister responsible for culture member;
  - Minister responsible for tourism member;
  - Minister responsible for internal affairs member;
  - Minister responsible for justice member;
  - Minister responsible for health and social protection member;



- Minister responsible for agriculture and rural development member;
  - Minister responsible for the protection of entrepreneurship member;
  - Head of the Academy of Sciences member;
  - Head of INSTAT member;
  - Director of National Diaspora Agency member;
  - Head of NAIS (National Agency for Informative Services) member.
3. The head of the NAIS, the head of the National Diaspora Agency, as well as members of the inter-institutional working group, conduct periodic meetings (every 6 months) for the evaluation and coordination of the institution's information pages.
  4. The head of the NAIS is charged that, within 5 (five) days from the entry into force of this order, determine the coordinators for each responsible institution.
  5. State Minister for Diaspora, Ministry for Europe and Foreign Affairs, Ministry of Finance and Economy, Ministry of Education, Sports and Youth, Ministry of Culture, Ministry of Tourism and Environment, Ministry of Interior, Ministry of Health and Defense Social Affairs, Ministry of Agriculture and Rural Development, State Minister for the Protection of Entrepreneurship, Academy of Sciences, INSTAT, National Agency for Information Services (NAIS), National Diaspora Agency for the implementation of this order.

This order enters into force immediately.
